Senator Anderson –

• The 2023 long session was interesting. Had a request early in the session for additional OOST funding. Seems that it "got lost" likely due to that at that time it was anticipated that the State would be short on funds. Hopefully when we put in for funding in the future, we will be successful as we have good examples of why OOST exists as shown by the project presenters today.

## Representative Gomberg –

- Agree the Senator. We started the session with lots of time and no money and we finished the session with no time and more money than we thought would be available.
- As Dr. Chan stated, we need to know more about OAH and the California current. We do not know as much as we should before making long lasting decisions. An example of this is the wind energy farms proposed off the Oregon southern coast. Frustrated that the BOEM public comment sessions were only held in southern Oregon. We held an informal public comment session and put those on record for BOEM review. This will have a big impact on our environment and communities.
- We will continue to pursue Legislative funding for ocean science research. Followed by comments, questions, and discussion with Board Members.
