Brief Update – Potential for State Funds Related to Nearshore Research

Motion to authorize the chair to send a letter in support of the direct appropriation of the \$2 million dollars to the Oregon Ocean Science Trust (OOST), which has the Oregon Ocean Science Fund established within the State Treasury. These funds could be directed to further science and research on nearshore keystone species including sea otters, nearshore marine ecosystems, kelp and eelgrass habitat, and sequestration of the blue carbon.
